Textual Information()

In order to comply with Regulation 31(1)(b) in true letter and spirit and SEBI's Circular dated December 01, 2015, bearing Circular Reference No. CIR/CFD/DCR/17/2015, We have not been able to provide PAN details of some of the promoters as these promoters are not traceable. Further, we had been writing letters to promoters requesting them to provide the PAN details as well as to get their shares dematerialized. In this regard, the Company had also published notices in newspapers (both English & Hindi) dated 07/09/2016 and 06/09/2017 requesting the shareholders and promoters of the company to provide the PAN details as well as to get their shares dematerialized. The promoters of our Company i.e RCC Cements Limited have been holding shares in the Company since the company came out with its IPO and subsequent Preferential Allotment. With the passage of time, some of promoters might have shifted to other place without intimating their change in address to the Company. Hence, it seems our letters/communication have either not been delivered to them or the promoters are not acting to the Company's advice and are holding their shares in physical form. It is noticeable that these promoters had been holding those shares since these were allotted to them and have not been transferred to any other person and/or entity.
